## **IMPORTANT INFORMATION:**

In regarding INTERNAL ASSESSMENT FOR **FINAL AND PRELIMINARY EXAMINATIONS** of 13 Para Medical Courses, for the year 2025:

1. The students who are due to sit for the Preliminary Examinations and Final Examinations in August, 2025, are required to undergo Internal Assessment at their respective Institute in each segment i.e. Theory/Practical/Oral & Practical, of any of the Para Medical Courses in which they are being taught.
2. The qualifying "Pass Mark" in Internal Assessment is 50% each in Theory/Practical/Oral & Practical.
3. The students, who would obtain the qualifying 50% or more marks in Internal Assessment, would need to be declared by the concerned Institute as "Passed", and, names of such students are to be submitted in the prescribed **Slip Rolls**, issued by the Faculty Office, **within June, 2025** to enable the Faculty Office to issue Admit Cards in time for them.

The students who would not obtain the qualifying 'Pass Marks" in Internal Assessment, Admit Cards for them would not be sent by the Faculty Office.

4. Further to the above, Admit Cards to be issued to all such students subject to their fulfilling the following two conditions:-
  - a. Students are required to obtain Pass Marks (50%) in Internal Assessment in each segment (Theory & Practical) of a Para Medical Course.
  - b. Students are required to attain the minimum percentage in attendance (75%) in 1<sup>st</sup> year/2<sup>nd</sup> year classes.
5. In this context, it is to be noted that the Full Marks in each Theory Paper of each Para Medical Courses would be 100, and, it would also be 100 in Oral/Practical/Oral & Practical. The Pass Mark is 50% both in Theory /Oral/Practical/Oral & Practical.

**Supplementary Examination**  
**for all Para Medical Courses and for Diploma in Pharmacy Course**

Supplementary Examinations for Para Medical Courses would be held tentatively, within 2 (Two) months from the Date of Declaration of the results of the regular Preliminary/Final Examinations.

Similarly, the Supplementary Examinations for Diploma in Pharmacy Course would be held tentatively, within 2 (Two) months from the Date of Declaration of the results of the regular Part I and Part II Examinations in Diploma in Pharmacy Course.
